Also mentioned was the process and reported the noted difference from previous years was the number of parents driving their students to school creating some localized traffic issues which are being resolved.

  - 7.1 Hiring New Hires' & Resignations' Data and Trend Reports are included in packet- 72 hires, 87 resignations represented a higher-than-normal turnover for this time of year- most in the student support services department. HR Director, Christine Pemberton, informed that the current CT Criminal History Web System online registry requires a payment of \$90 prior to seeking employment was a burden to many seeking entry level positions. After an analysis of previous year's data, LEARN has put aside \$13,000 to relieve this burden to those most impacted to assist in the recruitment and retaining process.

For the first time, Convocation's was held as a Live Stream to 7 locations hosted by the Executive staff and included announcing the TOY awards. The theme for all of the LEARN agency was one of belonging. Mrs. Ericson informed the board of the Governor's Executive order to collect vaccinations as condition of employment. LEARN has developed an app to assist in gathering the data for this process.
